

WARRANT

All Air Conditioning compressors supplied by JAS Oceania are warranted for a period of 12 months from the date of purchase. JAS Oceania will accept a claim for warranty providing the following conditions are met:

- Flush the system.
 The system must be thoroughly flushed with an approved solvent to remove any debris or contaminants.
- 2. Replace the filter drier / accumulator and the T.X. Valve / Orifice Tube
- 3. The system must be charged correctly with a suitable refrigerant
- 4. All vehicle applications post 1994 must have the condenser replaced. These Condenser can not be thoroughly flush of debris or contaminants.
- 5. Fix the system fault.

All other air conditioning components are covered by a 12 month warranty and are subject to inspection by JAS Oceania staff.

SNOITIONO

All claims for warranty must be made within the relevant warranty period, by returning the product to JAS Oceania at the purchases expense. With completed warranty claim form and proof of purchase (invoice number). The warranty dose not apply to failure or damage to the unit caused by incorrect or faulty fitment, contamination by foreign materials or modification carried out by anyone other than JAS Oceania.

JAS Oceania liability pursuant to this warranty shall be limited to JAS Oceania in its discretion by either repairing or replacing the defective unit or providing a credit or refund of its original invoiced price. In no case shall this include any consequential or other costs of removal and refitting any unit.

REDIT POLICY

All Parts returned to JAS Oceania for credit must be returned within 30 days after Invoice date. Parts returned after this may not be accepted for credit.

Parts for return are required to be in condition as purchased, original packaging and in a resalable condition. Parts not returned in resalable condition may be refused or subject to a repackaging fee. Original Invoice number will be required for the credit to be processed and special buy in or Procured parts will not be accepted.

JAS Oceania supplies parts and components to Specialists with specialized knowledge of our parts and therefore whilst JAS Oceania at all times uses all means to identify the correct parts and or components, ultimate responsibility is on the purchaser to ensure compatibility before fitting. Because of the complex nature and possibility that components and or parts can be damaged by being fitted into faulty or incompatible systems they will not be accepted for credit once fitted.
